

# **MITSUI SCHOLARSHIP PROGRAM FOR INDIA PROSPECTUS FOR 2026**

## **1. Outline and Objectives**

The MITSUI SCHOLARSHIP PROGRAM FOR INDIA (hereinafter referred to as the “Program”) is established by Mitsui & Co., Ltd., in Tokyo, Japan (hereinafter referred to as “Mitsui”) in 2024. The Program aims to encourage Indian students who wish to study at a university in Japan and obtain a bachelor's degree thereby. The objectives of the Program is to support and assist the selected students to ;

**Firstly**, develop Indian human resources who are committed to Japanese society with excellent Japanese language skills and familiarity with Japan’s diverse culture and lifestyle, expecting such human resources to pursue their carrier in Japan or related to Japan.

**Secondly**, develop an international sensibility through daily life in Japan.

**Thirdly**, contribute to positive friendship between India and Japan in the long run.

The selected students would be able to make their best efforts in their respective fields so as to contribute to the development of India after finishing their studies in Japan, calling upon their experiences of living and studying in Japan.

Therefore, the selected students who have completed their studies in Japan under the Program would be expected to make their utmost effort to materialize the Program’s objectives.

## **2. Qualifications for the applicants (hereinafter referred to as the “Applicants”)**

- (a) *Nationality*: Applicants shall be citizens of the Republic of India.
- (b) *Age*: Applicants shall not be more than twenty (20) years of age as of April 1st, 2026 and unmarried.
- (c) *Academic Background and School Records*: Applicants shall have completed HSC (Higher Secondary Certificate) of CBSE or ICSE (or equivalent) board with marks of at least eighty-five percent (85%) or higher on their school records for the following subjects. In case the candidate has appeared in HSC examinations, they shall produce the SSC (Senior Secondary Certificate) passing certificate with minimum aggregate marks of eighty-five percent (85%).

**For Science background:** Mathematics, Physics, Chemistry and English.

**For Commerce background:** Mathematics, Economics, Business Studies and English.

- (d) *Japanese Language*: Applicants who possess a JLPT N3 or higher certificate or EJU result with high score at the time of application will be considered an advantage in the selection process.
- (e) *Health*: Applicants shall be healthy, both mentally and physically, and have no infectious diseases. Please obtain a Character certificate from the school and submit the same during application.
- (f) *Other scholarship*: Applicants shall not have been granted scholarships or financial assistance from other institutions or organizations at the time of application.

## **3. Application and Selection Procedures**

- (a) *Application*:  
Applicants shall submit the prescribed application form **by the Microsoft Form:**
- (b) *Selection Process*:  
Selection process shall be conducted as indicated in the chart below in a strict and fair manner based upon the standards and rules of the Program, by taking all data and test results into the consideration. There shall be no interference with the selection process.

(1) **The 1<sup>st</sup> Selection**

Eligible applicants who have made online application by the Microsoft Forms and meet the eligibility criteria will receive an invitation to submit the application documents as below.

**<Application documents to be submitted>**

- (i) Self-attested copy of student ID and Aadhar card ..... 1 copy each
- (ii) Letter of agreement signed by parents or guardians in English ..... 1 copy.
- (iii) Physical Fitness Certificate to be signed by Registered Medical Practitioner..... 1 original
- (iv) Certificate of TOEFL/IELTS or any other certificate issued by an internationally well-known language institution, if applicant has not studied English language in school ..... 1 copy each
- (v) Certificate of award or commendation issued by an internationally well-known organization, if any... ..... 1 copy each
- (vi) The results of the Examination for Japanese University Admission for International Students (EJU), or alternative documents that can adequately certify the applicant's academic ability, as well as documents concerning the selection results of other scholarship programs, if any. .... 1 copy each
- (vii) The Japanese-Language Proficiency Test (JLPT) certificate, if any. .... 1 copy
- (viii) Brief report on the intended field of study at university and perspectives regarding envisioned lifestyle and career path after graduation. The report must be typed and not handwritten.

**<Notes> If there is any deficiency to the application documents, the application is not accepted.**

(2) **The 2<sup>nd</sup> Selection**

Applicants who passed the 1<sup>st</sup> Selection will proceed to an online test, which includes English, Science (two subjects selected from Physics, Chemistry, and Biology), Mathematics (Course 2), and the Aptitude test.

(3) **The 3<sup>rd</sup> Selection**

An interview will be carried out by the Managing Committee of the Program as the final selection.

Precise hours and address of the 3<sup>rd</sup> Selection would be informed from the Program to the applicants who passed the 2<sup>nd</sup> Selection. Depending on the situation, the method of the 3<sup>rd</sup> Selection may be changed.

**<Notes>**

- None of the submitted documents would be returned.
- Examination and test of 1<sup>st</sup> Selection, 2<sup>nd</sup> Selection and 3<sup>rd</sup> Selection will be free of charge, but the expenses such as travel, lodging, medical check-up fee and others, if any, related to the selection procedure shall be borne by the

Applicants.

- The Program would send an announcement about the selection result only to the successful Applicants.
- Inquiries about the result of the selection process would not be disclosed and not be answered to the Applicants.

#### 4. **Pre-departure preparations for Japan**

Applicants who have passed the 3<sup>rd</sup> Selection (i.e., the final selection) would be called grantees (hereinafter referred to as the “Grantees”), and undergo a preliminary education in India in elementary Japanese language and orientation on topics such as Japanese life, climate, customs, manners, etc. for about one (1) month before leaving for Japan. Cost of such education and orientation would be borne by the Program.

Depending on the situation, the method of preliminary education may be changed.

#### 5. **Tenure of Program in Japan**

The tenure of the Program shall be consisting of the below two (2) items:

<Notes>

- Japanese language study is scheduled to be conducted at Tokyo Japanese Language Education Center of Independent Administrative Institution, Japan Student Services Organization, Tokyo, Japan or any other school designated by the Program (hereinafter referred to as the “JASSO”).
- The Japanese language training period at JASSO shall be 1.5 years, subject to shortening depending on the Grantees's Japanese language proficiency and shall be determined at the discretion of the Program.
- Entrance to and graduation from universities in Japan could only be achieved by the efforts and endeavor of the Grantees.
- The scholarship for the study at the universities will be provided until graduation at the university with a maximum of four years in any event.

#### 6. **Benefits Provided by the Program**

The Program shall provide each Grantee with the following allowances (hereinafter referred to as the “Scholarship”) only for supporting the Grantees’ living and studies in Japan, and any of which may be adjusted from time to time at the Program’s own discretion basically in accordance with the Clause 9 and 11 hereof.

##### (a) *Living Allowance:*

The sum of 145,000 Japanese yen per month would be given to each Grantee during the tenure of the Program until the graduation of the university with a maximum of four years in any event.

##### (b) *Transportation Charge:*

###### (1) Transportation from India to Japan:

An economy class one-way air ticket from Indira Gandhi International Airport (New Delhi) to Tokyo International Airport would be given to each Grantee before his/her departure.

###### (2) Transportation from Japan to India:

An economy class one-way air ticket from Tokyo International Airport to Indira Gandhi International Airport (New Delhi) would be given to each Grantee who would return to India, upon submitting an application, within 1 (one) month after the graduation of the university.

##### (c) *Arrival Allowance:*

The sum of 50,000 Japanese yen would be given to each Grantee upon arrival in Japan.

##### (d) *School Fees:*

Fees for the entrance examination and tuition at JASSO as well as at universities would be borne by the Program.

##### (e) *Accommodations, Meals, Local Transportation and Other Costs and Expenses:*

- (1) For the period of study at JASSO, Grantees shall reside at the dormitory of JASSO, or a similar place designated by the Program. The cost of such accommodation shall be borne by the Grantees. The Program shall provide a lodging subsidy of 5,000 Japanese yen per month per person to the Grantees.
- (2) During the period of study at university, Grantees shall reside at university dormitories, private boarding houses, or apartment houses, any of which shall be approved by the Program. The cost of such accommodation shall be borne by the Grantees. Any necessary key money and/or deposit money shall be borne by the Program. The Program shall provide a lodging subsidy of 25,000 Japanese yen per month per person to the Grantees.
- (3) The cost of textbooks necessary for the curriculum at JASSO and/or university in Japan approved by the Program shall be borne by the Program.
- (4) Meals, local transportation charges and other expenses shall be borne by the Grantees.
- (f) *Insurance:*  
Travel insurance, and accident insurance for the Grantees during the period of Program approved by the Program, shall be borne by the Program. (National health insurance premium in Japan shall be borne by the Grantees.)

## 7. Universities to be applied for Study

- (a) The Grantees may take entrance examinations at any national university and public universities in Japan. Should the Grantees wish to apply to any private universities in Japan, the Grantees shall first obtain prior approval from the Program.
- (b) The placement of the Grantees at universities and their major fields of study in Japan shall be subject to the approval by the Program, after taking the Grantees' wishes, related records and results of the entrance examinations into consideration.
- (c) Change of major or fields of study after entrance to the university shall not be allowed.

## 8. Fields of Study

- (a) Study of Sciences and Engineering (4-years undergraduate course), such as;

Mathematics, Physics, Chemistry, Information & Computer Science, Biology, Biophysics & Biochemistry, Geology, etc.
Civil Engineering, Architecture, Urban Engineering, Environmental Engineering, etc.
Mechanical Engineering, Precision Engineering, etc.
Ship Building & Ocean Engineering, Aeronautics, etc.
Electrical Engineering, Electronics, Information & Communication Engineering, etc.
Metallurgy, Materials Science, etc.
Applied Chemistry, Chemical Engineering, etc.
Industrial Engineering, Factory & Production Management, Plant Management, etc.
Agricultural Engineering, Forest & Fishery Science, Agricultural Chemistry, Agro biology, Food Engineering, etc.

- (b) Study of Social Sciences, Business and Commerce (4-years undergraduate course) such as;

Civil Law, Public Law, Political Science, etc.
Economic Theory, Economic History, Economic Policy, etc.
Enterprise Management, Accounting, Commerce & Marketing, Finance, Insurance, Industrial Relations, Econometrics, International Economics, etc.

Due to course term limitations, the Grantees are not permitted to choose medical science, pharmaceutical science, or veterinary science as their fields of study. In addition, faculties specializing in arts, physical education, nursing, caregiving, or similar highly specialized fields are not eligible.

## 9. Duties during Program

- (a) The Grantees shall submit to the Program a record of academic achievement at the end of each school term and a

- status report on his/her studies and life periodically in a form and substance acceptable to the Program.
- (b) The Grantees shall participate in meetings to report updates held by the administration office regularly.
  - (c) The primary focus of the Grantees shall be on educational endeavors during the term hereof. Accordingly, the Grantees may not work, earn a profit or commercial benefit of any kind or character, or perform any types of compensated services for any employer or person during his/her stay in Japan, with or without compensation, except after having obtained the prior written approval of the Program in each case. In the event that the Grantees nevertheless receive any direct or indirect compensation or economic profit in violation of this Clause 9 (c), the Program may freely adjust any of the subsidies and benefits provided under this Program in its sole discretion.
  - (d) The Grantee shall not make any untrue, false, or misleading claims, expressions, or evaluations in connection with the Program.
  - (e) The Grantee shall remain unmarried during the tenure of the Program period.
  - (f) The Grantees shall attend scholarship award ceremonies and networking events among scholarship recipients organized by the Mitsui during the Program period, if any.
  - (g) The Grantees shall be willing to actively participate in the scholarship activities as scholarship graduates even after the Program has ended.
  - (h) The Grantees shall cooperate with the survey on their career path after graduation from the university.
  - (i) The Grantees must cooperate with the request for information provision for the purpose of disclosing and publishing the Program as part of Mitsui's social contribution initiatives.

#### **10. Duties after studying in Japan**

The Grantees shall, firstly, make their best efforts to be an active and able promoter of friendly understanding between the Republic of India and Japan and the people of both countries, and secondly, the Grantees will make their best efforts to play a leadership role in their preferred fields so that the Grantees can contribute to the development of India based on the experience of having studied and lived in Japan.

#### **11. Events of Termination**

- (a) The Program may at any time terminate or discontinue the provision of the Scholarship and the Program on the occurrence of any of the following events:
  - (i) Any false statement has been made on the application dossier.
  - (ii) Any article of the Grantee's pledge to the Program is violated
  - (iii) The Grantee faces difficulty in continuation of his/her studies due to health reasons.
  - (iv) The Grantee violates rules and regulations of the JASSO and/or universities as well as laws and regulations of Japan.
  - (v) The Grantee has no promise for academic achievement within the designated period (e.g., failure to achieve a satisfactory level in the Japanese language or in his/her major subject, or it becomes obvious that the Grantee will be unable to complete the course within the four years period of study because of poor academic grades or suspension or absence from the university).
  - (vi) The Grantee has failed to submit activity reports and transcripts and meet with the administration office staff as described under Clause 9.
  - (vii) The Grantee has failed to be accepted or enrolled in a university.
  - (viii) The Grantee has transferred to or withdrawn from the university without the prior consent of the Program.
  - (ix) The Grantee commits any action showing extreme misconduct or other improper conduct as a scholarship student.
  - (x) The Grantee has been suspended from a university for an extended period of time.

On the occurrence of event(s) as stated in this Clause 11, the Grantee shall immediately return to India, upon the instructions of the Program, and except in case of the events stated in sub-paragraphs (iii) and (vii) in Clause 11, the Grantee shall promptly refund in one lump sum payment the entire amount of Scholarship paid by the Program to the

Grantee under the framework of the Program.

- (b) Entrance to and graduation from a university in Japan shall depend solely on the efforts and determination of the Grantee. The Program does not guarantee, nor is it responsible for securing, such entrance or graduation.
- (c) Since this Program is a study abroad program in Japan, if the Program determines that it is difficult to dispatch the Grantees due to epidemics, natural disasters etc., the Program may cancel to dispatch the Grantees.

## **12. Privacy Policy**

Documents submitted to the Program at the time of application for this Program or after selection as the Grantees, will be used for Grantees selection, academic support, and system operation in accordance with the personal information protection policy set forth by Mitsui. Applicants' information shall be provided to subcontractors within the appropriate scope of this use and not be used for any other purpose. Applicants are deemed to have agreed to this policy before submitting their applications.

## **13. Governing Law and Jurisdiction**

This PROSPECTUS shall be governed and construed in accordance with the laws of Japan.

## **14. Modification**

Mitsui reserves the right, at its sole discretion, to modify, amend or alter the terms and conditions of the Program, including but not limited to the benefits mentioned in this Prospectus, at any stage, without any prior notice or republishing the Prospectus.
